This agreement constitutes: 1) A Contract for wedding photography services; 2) A model release.

Upon signing, Matt Emrich Photography will reserve the time and date agreed upon, and will not make any other arrangements for that time and date. For this reason, all retainer fees are nonrefundable. Upon signing of this contract, a retainer of 1/3 of the total invoice is required to reserve the date.

The remaining balance is due one week prior to the wedding. Payment of retainer binds the Bride and Groom for the entire Contracted Amount. Any cancellation or postponement of this contract by Client within 180 days from the contracted wedding date will result in a forfeiture of clients' retainer and, in addition, client will be held liable for any and all remaining balance, not including album purchases (pending album stipulation, below). Cancellations or postponements made by Client at least 180 days in advance of the contracted wedding date will result in a 50% forfeiture. Any money paid towards an album, whether partially or in full, shall be fully refunded if the album order is canceled at least 45 days from the contracted wedding date. Any postponement or cancellation of this contract by Matt Emrich Photo shall result in a 100% refund of all monies paid by Client. Matt Emrich Photography will take great care with exposure, storage and delivery of photographs. However, in the event of failure to deliver photographs for any reason, liability is limited to return of all payments made. The contracting parties agree that in the event it is necessary to retain the services of an attorney for the collection and enforcement of this agreement, the client agrees to pay photographer's actual costs for attorney fees and other expenses incurred in the collection and enforcement of this agreement. Venue of all legal action will be in Lane County, Oregon. I reserve the right to change my prices and services. Goods and services purchased in this contract are guaranteed to stay at the stated price. All future purchases must be made at the current price for that item at the time of purchase. **Model Release:** I hereby give to Matt Emrich Photography the unrestricted right and permission to copyright and use, re-use, publish, and re-publish photographic portraits or pictures of me without restriction as to changes or transformations, for the purpose of promotion, advertising, trade, or any other purpose whatsoever. I hereby relinquish any rights to examine or approve the completed product, the copy or any printed matter that may be used in conjunction therewith, or the agreement shall be binding upon my and my heirs, legal representatives and assigns. **What are the photos used for?** Mostly for my own personal business promotion. I also frequently license images for use by the other wedding vendors involved in your wedding, as well as occasional magazine and book publishers.

This contract includes the following items and services only:

Matt Emrich will be the photographer. All-day coverage up to 10 hours. No limits on number of images taken. Matt Emrich Photography retains the Copyright to all images produced. You have unlimited Printing Rights for life. Wedding packages include:

High resolution images on DVD (in color and black & white): \$1200

High resolution images on DVD (in color and black & white) and one 35-page, 10x10 inch photo album: \$1800

High resolution images on DVD (in color and black & white); one 35-page, 10x10 inch photo album; two MiniBooks: \$2100
(larger MiniBooks also available, please inquire about pricing)

Weddings further than 125 miles from Eugene, Oregon are subject to a nominal travel fee of \$50; also, if an overnight stay is required, an additional \$300 will be added to the total cost. Weddings outside the continental United States shall be negotiated on a per-case basis and begin at \$2400.
